Inviting reference to the captioned subject, we wish to reiterate and record our submissions as hereunder for your information and kind intervention in larger interest of our members.

1. Many members of our State Unit are deeply aggrieved by denial of Repatriation under ATE 2019 under various grounds, as per provisional list declared by the bank. You must be aware that large section of officers are posted outside their place of domicile for many years and yet marked ineligible to repatriate this year also. Referring to the deliberation of the undersigned on the subject at the above said meeting, **we once again convey the sentiment of our membership to nominate in-service leaders of our Federation to negotiate on important Policy issues with the bank till the completion of legal process pending at Hon'ble High Court, Calcutta to ensure resolution of large number of pending issues of our members** for the reason of imbroglio caused due to discontinuance of bilateralism between the Bank and our beloved Federation since last two years.

In continuation to my submissions at the captioned meeting, the undersigned expresses deep remorse at denial of representation of Elected Office Bearers of West Bengal in the Central Executive Committee of our Federation even after series of letters/reminders addressed to the General Secretary of our Federation in the matter after conclusion of State Conference in November 2018. Our members in West Bengal were hopeful of Co-options of Elected State Office Bearers in the CEC of our Federation at the above stated meeting but were dejected at non-adherence to provisions/conventions, leading to non-representation of the largest State Unit in the Federation, in spite of our paying Rs. 1.67 Lac approximately per month as affiliation fees to our Federation.

I hope that you shall find our concerns in order of fundamental tenets of the functioning of Trade Union to direct our Federation for needful resolution at the earliest to protect safety, security and dignity of our officers.
