You by now may have come to know that our Odisha General Secretary Mr. Ashok Dash has sought affiliation from AIBOC affiliated union in our Bank. By knowing this many of you may be little worried and shocked on this unfortunate happening. We have been receiving numerous phone calls from our members in Odisha enquiring how this has happened as they didn't have any mandate to change their affiliation. Almost all the members are very much agitated on being uprooted from their home. They are bent upon to teach these perpetrators of fraud a life time lesson.

Comrades, this coup has been staged in a very secret manner. All of you know that ever since West Bengal unit has joined us after being disaffiliated by SRC due to massive blow he received at the hands of young and energetic team led by Com. Ajoy Mondal, Com Lucky Bhavnani, Com Deep Prakash Rawat, Com Ratish Barman and other leaders, SRC was desperate to retaliate. First he tried to engineer mass defections in Delhi unit by luring President R. C. Chaudhary just 2 months before his retirement. Mr. Chaudhary was facing charge sheet for indiscreet sanctioning of loans and advances during his tenure as BH of Panipat branch which have turned NPA to the tune of Rs.150 crores. SRC promised him safe retirement but he was punished with downing of Scale from 3 to 2 and a cash penalty of Rs.4.00 lakh. However, as Delhi unit was brought up and nurtured by Setia ji, no dent could be made there. Then he tried to woo our President of Uttrakhand unit Mr. Deepak Rawat by promising him General Secretary post of Uttrakhand. He too was deceived and made Vice President only. against Basa ji. So he lured him and engineered a silent coup. Ashok Dash was on the job of cheating simple and innocent members of Odisha. He visited some branches in Bhubaneswar and got one Blank Excel Sheet signed from members on the pretext that same are required to update information in HRMS package. Believing on his words members signed the blank form.

Thereafter, Ashok Dash prepared one forwarding letter addressing SRC for seeking affiliation from AIUCBOF and annexing signatures of some members in Excel sheet. Hence he cheated simple members and fraudulently used their signatures.

For information of all of you neither any EC meeting nor any General Body meeting was called to seek approval for change of affiliation which is against Constitution. On learning these developments Basa ji who was in Delhi on Sunday for going on tour of Meerut Zone branches with Setia ji rushed back to Bhubaneswar for damage control by some greedy, spineless, characterless and rootless leaders. You must know that Odisha unit was brought up and nurtured by Basa ji. He commands love, affection and respect of almost 99% of Odisha Officers. Basa ji is a Fatherly figure for them. We at our end are solidly behind Basa ji and confident that no damage will be done in Odisha also. SRC will again fail in his misadventure miserably like Delhi and Uttrakhand. Till Basa ji there, no one can even inflict scratch on our Odisha unit.
