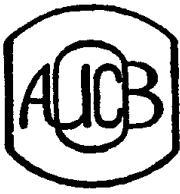
REF: Payment of Annual Premium for Medical Aid provided by AIUCBOF Welfare & Benevolent Trust to its Life Members

We have received grievances from number of our members regarding Medical Aid Scheme runs by AIUCBOF Welfare & Benevolent Trust. Unlike previous years, till date no communication has been issued from the Trust regarding payment of Annual Premium of Medical Aid Scheme. Earlier, Trust used to issue circular for renewal by the month of April of every year for the Life Members.

You must be aware that Life Members have opted for this medical aid scheme to meet their medical expenses. However, it is very unfortunate that during the time of pandemic Covid – 19, when need of Medical Aid is at its peak, in place for extending additional support, AIUCBOF Welfare & Benevolent Trust is not providing regular facilities to its Life Members for reasons best known to them only.

However, you are once again requested:

1. Immediately issue communication to all Life Members for payment of Annual Premium of Medical Aid Scheme.

2. Life Members should be allowed to make online payment directly in the account of AIUCBOF Welfare & Benevolent Trust and submission of form through email, as movements are restricted due to Lockdown.
 3. Keeping in view of increased medical expenses, Trust may increase the quantum of sum assured to Rupees 4 Lac for this Financial Year.
 4. Coverage for all Life members who have paid their premium previous years, should be continued till the time of issuance of communication for payment of premium for this Financial Year.

We once again need to record that even last year, the premium cheques of our members were returned uncollected without informing any logical and acceptable reasons. Due to non availability of the Medical Coverage, many of our members suffered huge financial expenses as they were not covered under the Medical Scheme, which was arbitrarily denied by you to the Life Members.

We await your immediate response in the matter.
